- The Homeowner reserves the right to immediately terminate this Agreement and remove Guest and their party from the property for violation of Rental Rules with no refund.
- Guest must be 25 years of age or older to rent.
- No Smoking is allowed anywhere on the Property.
- The Check-in and Check-out dates and times must be adhered to unless agreed to inwriting by the Homeowner or an Early Check-in/Check-out upgrade has been purchased before the check-in date.
- No Events allowed.
- Local ordinances forbid loud noises/music between the hours of 10:00pm and 7:00am.
- Bears frequent the area, so do not leave any food/trash in your car or on the deck during your stay.
- The Property is not "Child Proof" and therefore Guest is solely responsible for ensuring the safety of any children traveling with them. Poisonous cleaning products and uncovered electrical outlets are within reach.

#### 6. Access

Guest shall allow Homeowner access to the property for purposes of repair, inspection, or emergency.

Homeowner shall exercise this right of access in a reasonable manner by giving at least 2 hours notice (unless in case of emergency).
